From the Editor

The I-STOP legislation, passed in 2012, was New York State's effort to confront the growing epidemic of opioid abuse. For the most part, it has been successful in decreasing the number of opioid deaths by overdose. However, there are some aspects of the law which have led to unintended consequences. One of those consequences is the way opioids are prescribed and dispensed.

My wife suffers from chronic pain and takes an opioid for that pain. She has had numerous back surgeries in an attempt to overcome the pain. She just had a second spinal fusion. Her first was in December 2014 when she had L4, L5 and S1 fused. I remember vividly the pain she experienced when she woke up from the surgery. The nurses kept her in the recovery room for an extended period of time trying to get her pain under control. When she came up to her hospital room, she was still screaming in pain. And she has been in pain ever since.

She just went through another fusion, this time fusing L3 and L4. She now has eight 3-inch screws in her back with rods connecting the vertebrae. She takes several different pain medications for the pain she experiences, one of them oxycodone. She gets a thirty day supply with each prescription. However, she cannot receive the next prescription until day one of that prescription. You may think, so what? Certainly that is sufficient. The prescription runs out and the next day you get a refill. What's the big deal?

For a person in constant pain, that can be a very great big deal. I have seen my wife walk around like a ninety year old woman on that first day of the new prescription, waiting for the pharmacy to open so she can get the new scrip. In this day and age, that should not happen. She has spoken with the pharmacist to see if she could pick up the scrip the day before, late in the day. She has been told no time after time. It has to be on the first day of the prescription. Occasionally, she may have the doctor call for an early refill, but that is only under special circumstances.

This makes no sense to me. What difference does twelve to fifteen hours make? If she were able to pick up the prescription the night before, she would be able to take the medicine first thing in the morning and not have to wait until later in the day for that initial dose. You may say what difference does a few hours make as to when the medicine is taken. For a person suffering from chronic pain, it can make a very big difference.

We are taught to first do no harm. I think the I-STOP legislation is doing harm to those in chronic pain who need these medications to help them live a more normal life. These medications are there to do just that. To not allow refill the evening before the first day is short sighted. I suggest we loosen the regulations just a bit to allow those in chronic pain to pick up their scripts the night before they run out. That way, the medicine can be dosed appropriately and the patient can be helped. Isn't that what do no harm means?

I hope no one reading this suffers from chronic pain. It is debilitating. It ruins your life. If you do suffer from this, you understand what I am addressing here. You understand what a few hours can mean. You understand the need for a more rational way to dispense these drugs in a more timely manner. I hope someday, this will happen. Chronic pain

They also calmed my fears and worries ... seeing such a small baby with so many tubes and wires connected to machines was extremely scary for me.

Although RSV is a virus and cannot be treated by medications, and is not preventable by vaccines, I still strongly recommend and encourage all children to get their vaccines as recommended by doctors. It helps build their immune systems, which in turn can help them fight off viruses such as RSV.

sufferers need to be heard, for you suffer in silence. Let your voices be heard. Get in touch with your state legislators. Push for a change in the law which would alleviate some of the pain you experience, which could be avoided by a more rational dispensing policy.

MODERN CERAMIC RESTORATIONS

COURSE DESCRIPTION:

This will be a review of ceramic materials available for restoration of both natural teeth and dental implants with a focus on high strength ceramics including lithium disilicate and full contour zirconia materials. Physical properties will be discussed only as a means to distinguish between material categories and understand the rationale for clinical utilization. Tooth preparation concepts will be discussed as a means to ensure maximum physical properties in the restoration. The choice between conventional cement and adhesive bonding will be presented as a foundation to ensure long term success of the ceramic restoration. Research evidence and clinical case examples will be used to discuss and illustrate materials and recommended clinical applications for adhesive ceramics and all-zirconia restorations.

COURSE OBJECTIVES:

- Provide information on modern ceramic materials with a focus on lithium disilicate and full contour zirconia.
- Provide information on conventional and adhesive cementation materials and techniques to maximize clinical outcomes with ceramic restorations.
- Provide current clinical research evidence on the long term success and clinical limitations of modern ceramic restorations.

SPEAKER:

Dr. Fasbinder is a Clinical Professor in the Department of Cariology, Restorative Sciences and Endodontics at the University of Michigan, School of Dentistry. He is board certified in General Dentistry by the American Board of General Dentistry. He also maintains a part-time private practice in Ann Arbor, Michigan.

Dr. Fasbinder directs the Computerized Dentistry Unit at the University of Michigan School of Dentistry that is dedicated to research and education on CAD/CAM dental systems and ceramic materials. The CompuDent Unit has been a leader in education and research with chairside CAD/CAM systems, digital impression systems, and ceramic restorations since 1993 resulting in numerous publications.

Dr. Fasbinder has delivered advanced education courses on digital dentistry for over 20 years and is a frequent speaker on ceramic-based dentistry and digital dental systems at meetings and conferences in North America and International locations.

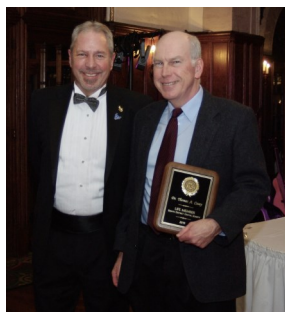
2019 President's Reception

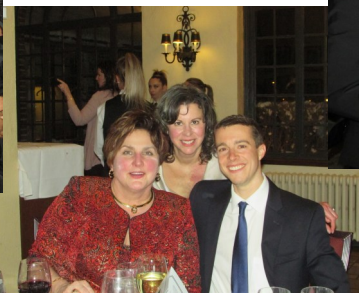

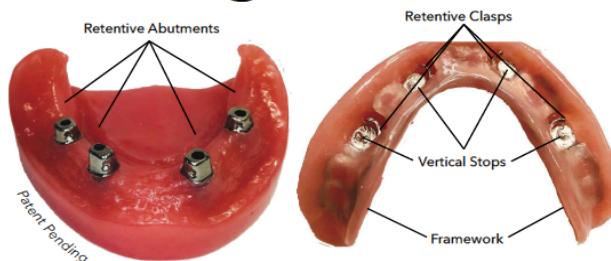
