#### FROM THE EDITOR

When I was a senior in dental school, we had to take a regional board to qualify for licensure in the Northeast region of the United States. As we all know, this was a two-day, pressurepacked exam which could determine if your last four years of education would be worth the time and treasure invested



or did you just waste four years of your life. Of course, if you failed, it was not the end of the world, but it did delay your entry into that world.

However, this would only qualify you to be able to secure a license to practice dentistry in only those states recognizing the Northeast Regional Board (NERB). If you wanted to practice in a state not recognizing the NERB, you had to endure another board examination for that state. Which for most people was another roadblock to licensure in the state where you wanted to practice. I will not go into the logistics of such an attempt, but they would be significant. To my young, inexperienced mind, this did not seem to be very fair.

I did not know at the time how some states were very protective of the dentists practicing in that state. Does Florida ring a bell? I also did not see how a pressure-packed exam could determine your level of competence in doing

dentistry. To me, all it proved was you were able to perform dentistry in an extremely high-pressure situation to someone else's arbitrary standard of excellence. My feelings were, if the dental schools were doing their job correctly, graduates of the school should be able to do dentistry safely and effectively on patients once they graduated. There should be no reason for such an examination. Sorry, but I was young at the time.

Well, I did pass the NERB and was able to secure a license in Connecticut where I studied orthodontics because Connecticut recognized the NERB exam. All I had to do was take an exam about the dental laws in Connecticut and pass. When I left Connecticut and came to Buffalo, I did not have to take any exams because I had a Connecticut license and, through reciprocity, I was allowed to obtain a New York State dental license.

Most states now have reciprocity and recognize your license as evidence you are a capable dentist, and this will allow you to obtain a license in such a state. However, you still must pay that state's licensing fee to get the license. If you live near the border of a state and want to practice in both states, you need to be licensed in both states and you need to pay two licensing fees. I understand this but it can get expensive.

This may end in the future with the implementation of the Dentist and Dental Hygienist Compact. The Dentist and Dental Hygienist Compact is an idea begun by the Department of Defense to aid military dentist and hygienist spouses to have license portability more easily. Since military personnel are transferred often, dentist and hygienist spouses must secure licenses in any area they may be transferred to. The Council of State Governments (CSG), the ADHA, the American Dental Association (ADA), and a team of other oral health stakeholders developed the compact over the course of 18 months in 2021 and 2022. (1) The compact allows those who qualify to practice in any state that is a member of the compact.

This is true license portability. Right now, the Dentist and Dental Hygienist Compact is in its infancy. However, it reached its first milestone when Maine became the seventh state to become part of the Compact. The other six states are Kansas, Virginia, Iowa, Washington, Tennessee, and Wisconsin. Seven states had to become members for this idea to move forward. To become a part of the Compact, a state legislature must pass legislation allowing that state to join the Compact. Because Maine became the seventh state, a commission can now be created with one representative from each state to create an application process and oversee vetting applications. The first compact privileges are expected to be issued in approximately one year.

This idea has merit. It allows true portability for dentists and hygienists to move to other states without the onerous hurtles some states place in their way. Florida, are you listening? And to all the other states who are not participating, it is time to move into the 21st century. Our population is more mobile now than it has ever been. People are transferred all the time. Spouses who are dentists or hygienists will benefit from this, as will all dentists and hygienists who desire to move but are inhibited by the prospect of jumping through regulatory hoops to obtain a license to practice in the desired state.


This is a win-win for everyone. Dentists and hygienists get license portability, states get a chance to help serve underserved areas, and patients get better dentistry. Sounds like a good thing to me. For my entire career, I have been calling for license portability. Hopefully, someday soon, the Dentist and Hygienist Compact will be the answer to that clarion call.

#### **EXECUTIVE DIRECTOR'S NOTE**

Fall is slowly trending forward with the start of Bills Training Camp, but there still remains a good stretch of summer to enjoy. I hope you, your family, and staff are able to relax a little and take in the great, and, at times, interesting weather patterns we have had this season.

In my last bulletin report, I highlighted five important trending shifts in programs and services in the tripartite, and while many are moving forward, we have experienced a slight delay in the new digital transition of the membership platform for Fontiva/Salesforce, which was scheduled for July 8th. That is now planned for September 1st, provided final testing and assessment protocols are worked through.

There will be five (5) pilot states adopting a new membership model in 2025 and they are currently working on mechanisms of support between ADA, state and local component functionality. At the ADA Summer Conference I attended, it was shared how this process is working within three of the five states, but it will remain somewhat specified by each state on how it will be supported top down. This is due to the nature and operational structure of each state's system, which are unique and varied. There will be a bundling of sorts between each entity to structure membership benefits, programs, and services, and tailor them to your individual needs and interests, much like an Amazon or Netflix experience. In this way, the ADA hopes that creating a better member experience digitally will enhance the overall targeting of actual support and a leveling of membership dues with price structures for each of them. While this bundling concept will be a work in progress, it is not well known how NYSDA and local components in our region will be onboarded to support this feature, how revenue will be shared, and what it will look like. It will take some time for the actual fine tuning to be put in place and move forward; stay tuned.

Locally, we are working to redefine the Foundation and its mission/vision in the Society and its purpose moving forward. In 2006, the Foundation made structural changes in which some programs ended, and the purpose and outreach of support was redesigned. Back then and continuing through today, funding to support our Foundation was made through continuing education (CE) revenue, sponsorships and grants. We now realize that CE funding is shrinking, due to declining participation, and the ability to raise funding needs to be reimagined for existing services and outreach and how best to support them, or even which ones should be a continuing priority? If you have ideas or suggestions, please contact me.

We are also working on the 2025 calendar for programs and services. While many strongly supported and beloved services and programs will remain, we also need to understand that all these efforts require not only support for them in terms of participation to make them viable, but that they also cost the organization money. This year we had to tighten our belt a little on some efforts to ensure we are fiscally responsible. We've operated at a small deficit, but we are hopeful 2025 will be a better year for endorsement and ongoing sponsorships and perhaps new foundation grants.

This past year I had the opportunity to serve as the President of the Association of Component Society Executives of the ADA (ACSE). I have been a member of the leadership group since 2022, taking over for Chris Klimecko when he retired as the Secretary/Treasurer. Overall, it has been a positive experience to learn more about operations nationally at the ADA as well learn from colleagues on how best they serve their members. It was a great time in my development as your local ED and I want to thank the Society leadership over these past three years for supporting my work and allowing me to be at important meetings and functions, which required travel and out of town time. I also have been asked to coordinate the NY ED group as well, which is an honor to support our state concerns with my counterparts.

#### MEMBERSHIP RENEWAL AND WAIVER OPTIONS

Every year there is the annual renewal of your membership through the ADA and NYSDA in some shape or format. There are also many options to consider depending on your current state of work, retirement, and life member status. For some, there are also occasional hardship or special circumstances that may result in a member not renewing their dues and falling away from collective support.



We all can sympathize with those changes and uncertainty. I think we all know someone who has had an unforeseen situation and is not always certain of what to do, so in some cases, they choose to end their membership.

We want members to know there are options to consider before you actually stop making any membership payments, paying dues and ultimately lose your tripartite benefits. For many years, both the ADA and your state association have supported a Waiver process to allow you to remain active while paying little to nothing for a period of time to remain an active member. The areas that qualify for this waiver include the following: significant financial hardship, including temporary or permanent disability, catastrophe, parental leave or medical illness.

Perhaps you are now fully retired from practicing, but teaching part-time at the dental school, this is a legitimate financial issue and may qualify for a waiver. Perhaps you or your spouse has undergone a serious medical issue and you have to take time from work to support your or their care and can no longer work a full-time schedule for an extended period of time, this is a legitimate claim for a waiver.

There are certainly a variety of scenarios that may qualify for consideration. So, if you find yourself or know of a member who may be, let them know they can apply for a waiver and be granted one for up to a year.

Please call the office at 716-995-6300 if you find yourself in this set of circumstances. We will email or mail you a form to complete based on your current state and process it to the state association for review and approval.

While approvals are generally a week or more in terms of a confirmation, they also may require more details to make a valid determination. Just because our office may affirm the waiver, it is really up to the Membership Team at NYSDA to approve and process the request. We want all our members to know, they have options.







### BECOME FAMILIAR WITH NALOXONE & SAVE LIVES

Drug overdoses have become the leading cause of accidental deaths in the US, with almost 150 lives lost every day. The major reason for this is the abundance of Fentanyl in the drug supply. Much of it is in the form of a fake prescription pill in which a single dose can be lethal. Everyone needs to know that recreational drugs are now laced with Fentanyl which is fifty times stronger than heroin. Last year, 112,000 Americans died from drug overdoses.



In many cases, victims unknowingly take drugs like cocaine, fake painkillers, Adderall and even marijuana, that contain Fentanyl. As health care providers, we should be able to recognize and treat overdoses.

Opioid overdoses have three cardinal symptoms, shallow, slow or stopped breathing, a decreased level of consciousness and pinpoint pupils. Other symptoms include a slower or absent pulse, pale clammy skin, blue lips or fingernails, gurgling noises or vomiting. If you suspect an overdose, call 911 and then administer Naloxone. Naloxone, or Narcan, attaches to receptors in the brain and replaces opioids that are there. It is highly effective in reversing opioid overdoses and easily administered as well as safe to use. Naloxone will do no harm to the person if they are not having an opioid overdose. It does not interact with medications other than opioids and there are no contraindications to it.

Narcan is now deregulated and can be purchased at any pharmacy. If you to go the OASIS Harm Reduction website you can get free Naloxone as well as drug testing strips that identify if a drug has Fentanyl in it.

The difference between life and death can be the availability of Narcan and it needs to be in your office emergency kit. You should even keep it in your car in case you come across a victim of an overdose. The opioid epidemic affects all of us. The life you save may be someone you know and love.

Dr. Amy Bryan is the chair of the NYSDA Committee on Substance Abuse and Well Being. ## Closed Claim Summary



### Noncompliant Patient Alleges Failure to Diagnose

This Closed Claim Summary is based on an actual claim and has been adapted for educational purposes.

This is a case of a 48-year-old man who presented as a new patient for evaluation of a lesion on the right side of his tongue. The patient initially delayed this first appointment with the insured for more than a month due to insurance coverage reasons. On the patient's first visit, the doctor documented a 2 x 1 cm white and red lesion that the patient reported had been present for about eight months. Our insured recommended the lesion be biopsied and tissue samples were sent to a lab that same day. The patient presented for two post op visits over the next two weeks and the insured documented that the patient was healing well; however, the pathology report had not yet come back from the lab. The doctor informed the patient that results would be delivered over the phone once the report was received. The pathology report, which was received the next day, noted "moderate dysplasia." The doctor asked his front desk staff to call the patient to schedule an appointment to discuss the results.

Three days later, the front desk staff at the dental office documented a call was placed and a voicemail was left. The following day, staff documented another unsuccessful attempt to reach the patient. A second voicemail was left instructing the patient to schedule an appointment to discuss the pathology results.

Almost two years later, the patient returned to the insured's office with complaints of pain in a maxillary tooth. The doctor documented a recurrence of the tongue lesion and referred the patient to a local OMS.

Nine months later, and without a visit to the OMS as recommended, the patient again presented to the insured, now with a complaint of a lump in his throat. When asked, the patient said he did not schedule the appointment with the OMS as recommended because the office was out of network, and he was not worried about the lump then but was now. Two weeks later, the patient visited the OMS, had the second biopsy performed, and learned that the diagnosis was now squamous cell carcinoma.

The patient required a hemiglossectomy and radiation treatment and was referred to medical oncology, which he initially refused. Eighteen months later, the patient was ultimately diagnosed with colon cancer, had a hemicolectomy and a PET scan revealed recurrence of the tongue lesion. The patient expired a few months after this diagnosis and a wrongful death lawsuit was filed against the treating dentist. Allegations included failure to diagnose oral cancer in a timely manner, failure to timely communicate pertinent pathology results, and failure to timely follow up with a patient presenting with possible pathology.

## Noncompliant Patient Alleges Failure to Diagnose

Plaintiff expert testimony opined that, had the patient's cancer been followed regularly after the initial biopsy by the dentist, the patient would not have had to undergo such an extensive procedure and his survival rate would have been higher. Experts obtained by Fortress noted that the lack of additional follow up by the dental office and limited documentation by staff could present challenges to the defense. However, Fortress experts also noted that the patient held responsibility for his own health and that the noncompliance with returning calls and scheduling follow up appointments contributed to the outcome. With consent of the insured, this claim resulted in a settlement, reduced from the initial demand, due to the decedent's own culpability.

#### **Risk Management Tips**

- Document the presentation of all lesions. If photos are not an option, consider documenting the size, color and texture of any lesions as well as any changes over time, including improvements.
- Develop and document office policies related to patient follow up. Keep in mind that policies
  related to patients who present with lesions and/or have pending pathology results may be
  different than those who require follow up to schedule subsequent treatment for an elective
  procedure.
- Train staff on management of noncompliant patients, especially those who present with lesions to mitigate potential allegations associated with failure to communicate or follow up.
- Practice how you might communicate responses to noncompliant patients who require
  additional follow up or treatment. Consider relaying to the patient a concern for their overall
  health and why treatment recommendations are being made.
- Communicate with referrals on a regular basis, to stay up to date with diagnoses, patient compliance with appointments and recommendations, treatment plans and any changes to those plans.
- Document any communication with patients, including details of any voicemails, texts, emails or messages left with the patient or their approved representatives and any communication with referrals.







